1) The below named individuals were selected to attend the Warrant Officer Candidate School (WOCS). Applicants should expect to receive a notification via email with their WOCS class date from the Human Resources Command (HRC) within 90 days after selection. To request a change in WOCS/WOBC class dates, please contact your WO Talent Manager (TM) for the WO MOS you were selected for. Please provide an explanation and timeframe. Your TM will advise the HRC WO Accessions Program Manager if approved. 2) Selectees can be removed by the applicant's commander for misconduct, loss of qualification or other disciplinary action per DA PAM 601-6, para 2-7a. Official requests will be submitted through command channels to HRC. HRC requires a memorandum

signed by a Company CDR. Email request to: WO Reserve Appointments and Accessions Branch, robert.a.harvey6.civ@army.mil and courtesy copy USARD HQs, Special Programs and Boards, usarmy.knox.usard.mbx.hq-g3-special-programs-and-boards@army.mil.

3) Selectees must hand carry a copy of their security clearance verification and all approved waivers (Medical/AFT/Moral/AFS/Age/Tattoos) when they report to Fort Rucker. All Candidates will hand carry HQ USAREC Form 3.1 (Results of Medical Examination) in lieu of the approved DD Form 2808. If a waiver is required, you must provide a copy of the approved waiver. If you don't have a USAREC Form 3.1, take your DD Form 2808 to school. The Results of Medical Examination must be no more than 24 months old from the date annotated in BLK 1 of DD Form 2808 through the projected WOCS graduation date for technical MOS candidates, and 18 months for aviation candidates (150A and 153A). Candidates possessing physicals, clearances or waivers that do not cover scheduled training attendance at WOCS may not be able to enroll in the program. If you have any tattoos, ensure that they are in compliance with AR 670-1, para 3-3 and DA PAM 670-1, para 3-3.

4) Personnel identified with an asterisk (*) are required to take and pass the Occupational Physical Assessment Test (OPAT) prior to reporting to WOCS per HQDA EXORD 071-17 and TRADOC TASKORD IN 163641.
