To the Applicant:

The authority for collection of the information requested on this form is contained in sections 332 and 335 of the Immigration and Nationality Act (8 U.S.C. 1443 and 1446). Submission of the information is voluntary.

The principal purpose for requesting the information is to determine whether a petitioner for naturalization is eligible to transfer his or her petition to another court. If the U.S. Citizenship and Immigration Services, District or Suboffice exercising administrative jurisdiction over the place where the court in which the petition is filed approves the transfer, copies of the form will be forwarded to the court wherein the petition is filed and also the court where the petition is to be transferred for their approval.

During the processing of the transfer application or in the course of the investigation, USCIS may as a matter of routine use disclose the information sought to federal, state, local or foreign law enforcement and regulatory agencies, the Department of Defense, including any component thereof, Selective Service System, Department of State, Department of Treasury, Department of Transportation, Central Intelligence Agency, Interpol and individuals and organizations. USCIS may require this action to elicit further information in order to carry out its functions. Information sought that indicates a violation or potential violation of law, whether civil, criminal or regulatory in nature, may be referred as a routine use to the appropriate agency, whether federal, state, local or foreign, charged with the responsibility of investigating, enforcing or prosecuting such violations. Failure to provide all or any of the information may result in disapproval of the transfer application.
