Student Data Groups

EDEN Student Data Groups will collect data about groups of students, for example, membership by grade level, gender and race/ethnicity. **Note: EDEN does not collect ANY data on individual students.** While most of the data collected through EDEN relates to students served in public schools and LEAs, EDEN does collect data on students in private schools and facilities when those students are receiving services or other benefits from a federal program.

As described in the beginning of this document the aggregate data reported for students at the school level can (but is not expected to) add up to similar information reported at the LEA level.

Definitions Standardized for 2006-07

As part of the drive to streamline data collections ED-wide, EDEN has standardized several definitions used through the EDEN data groups for 2006-07. Although some of the previous definitions were similar, they were not identical and states following the reporting requirements for various program offices to the letter were required to classify students differently for different programs. This standardization will reduce record keeping and reporting burden on the states and ultimately increase the level of data quality.

For the 2006-07 EDEN data set, three definitions have been adopted as ED-wide standards: Children with Disabilities, Limited English Proficient (LEP), and Migrant Students that are shown below. ED plans to adopt additional ED-wide standards for future EDEN data sets.

Children with Disabilities (IDEA) - Children having mental retardation, hearing impairment including deafness, speech or language impairment, visual impairment including blindness, serious emotional disturbance (hereafter referred to as emotional disturbance), orthopedic impairment, autism, traumatic brain injury, developmental delay, other health impairment, specific learning disability, deaf-blindness, or multiple disabilities, and who, by reason thereof, receive special education and related services under the Individuals with Disabilities Education Act (IDEA) according to an individualized education program (IEP), individual family service plan (IFSP), or service plan.

[Reference – Section 602(3) of IDEA]

Limited English Proficient Students (as known as English Language Learners) - In coordination with the State's definition based on Title 9 of ESEA, students:

- (A) who are aged 3 through 21;
- (B) Who are enrolled or preparing to enroll in an elementary school or a secondary school;
- (C) (*Who are i, ii, or iii*)
 - (i) who were not born in the United States or whose native languages are languages other than English;
 - (ii) (*Who are I and II*)
 - (I) who are a Native American or Alaska Native, or a native resident of the outlying areas; and

- (II) who come from an environment where languages other than English have a significant impact on their level of language proficiency; or
- (iii) who are migratory, whose native language are languages other than English, and who come from an environment where languages other than English is dominant; and
- (D) whose difficulties in speaking, reading, writing, or understanding the English language may be sufficient to deny the individuals (*who are denied i or ii or iii*)
 - (i) the ability to meet the State’s proficient level of achievement on State assessments described in section 111(b)(3);
 - (ii) the ability to successfully achieve in classrooms where the language of instruction is English; or
 - (iii) the opportunity to participate fully in society.

To be classified as limited English proficient, an individual must be A, B, C, and D. For C, an individual can be i, ii, or iii. If C-ii, the individual must be I and II. For D, an individual must be denied i or ii or iii.

[Statutory Reference – Section 9101(25) of ESEA]

Migrant Students - Students who are, or whose parents or spouses are, migratory agricultural workers, including migratory dairy workers, or migratory fishers, and who, in the preceding 36 months, in order to obtain, or accompany such parents or spouses, in order to obtain, temporary or seasonal employment in agricultural or fishing work (A) have moved from one LEA to another; (B) in a State that is comprised of a single LEA, has moved from one administrative area to another within such LEA; or (C) resides in an LEA of more than 15,000 square miles, and migrates a distance of 20 miles or more to a temporary residence to engage in a fishing activity. [Reference – 34 CFR 200.81]
