**GENERAL INSTRUCTIONS**

1. Applications must be typed.
2. Remove Copy 4 (APPLICANT) before mailing the application to the Directorate of Defense Trade Controls (PM/DDTC).
3. Attach one copy of the license to be amended. Include any proviso letter(s) and /or attachment(s).
4. The following types of amendments can be requested using this form: addition of a U.S. freight forwarder or consignor, correction of typographical error, or change in commodity source. This form cannot be used for substantial changes to the license such as additional quantity, commodity, country of ultimate destination, foreign consignee, end-user or end-use.

**SPECIFIC GUIDELINES**

- Item 2        Check the appropriate block. Only one license may be amended by each DSP-119, "Application for Amendment."
- Item 4        Should be as shown on the license to be amended.
- Item 5        Give name and telephone number of an individual within your company who is familiar with this application.
- Item 6        If more than one item on the license is to be amended with this application, list them in numerical order, separated by a comma (e.g., 6, 8, 24).
- Item 7        Follow the instructions carefully. Make sure the license number corresponds to the license you wish to amend. A total of four changes per license can be requested on this form. If you are amending more than four blocks on a license, attach two copies of a continuation sheet. The continuation sheet should contain the date prepared, license type, license number, and PM/DDTC Registrant Code.
- Item 8        For DSP-85s, make sure to list the correct DSS Cognizant Security Office responsible for administering the government-to-government transfer at the location where the classified article or technical data is packaged for shipment.
- Item 9        Enter complete address to which amendment should be mailed. Do not type "SAME AS ITEM 4."
- Item 10      Enter the name of the individual signing the application. Read the statement on the reverse of Copy 1 carefully, and check in the space provided if this amendment adds a party to the license such as a consignor or freight forwarder.
