

## SUPPORTING STATEMENT

### Justification for:

PD F 1851, " Request to reissue United States Savings bonds to a personal trust.

1. **Explain the circumstances that make the collection of information necessary. Identify any legal or administrative requirements that necessitate the collection.** Savings bonds may be reissued to name a trustee of a personal trust.
  
2. **Indicate how, by whom, and for what purpose the information is to be used.** Used to identify the securities involved and to establish the authority to reissue them. Without the information, the transaction cannot be completed.

Public Debt has been a leader in e-Gov, providing the public with options for conducting financial transactions online for several years. To provide our customers additional options for submitting information electronically, we are taking the following steps: a technical project team is exploring options (such as pay.gov) and will select the mechanism(s)/infrastructure needed; concurrently, reengineering of business processes (and forms) is being conducted as the result of a reorganization of our major business lines.

8. **What effort was made to notify the general public about this collection of information?** The Bureau's notice was published in the Federal Register on August 14, 2006, Page 46536. No comments were received.
9. **What decision was made to provide any payment or gift to respondents, other than reenumeration of contractors or grantees?** N/A
10. **What assurance of confidentiality was provided to respondents and what was the basis for the assurance in statute, regulations, or agency policy?** In accordance with the Privacy Act of 1974, information furnished by the public is assured confidentiality.
11. **What justification is there for questions of a sensitive nature?** There are no questions of a sensitive nature.
12. **What is the estimated hour burden of this collection of information?** The average time needed is 15 minutes per response multiplied by the estimated number of responses (50,000) reflects the total burden of 12,500 hours.
13. **What is the estimated total annual cost burden to respondents or recordkeepers resulting from this collection of information?** Estimated cost burden to respondents is not available.

14. **What is the annualized cost to the Federal Government?** The following factors were used to estimate the annual burden to this agency:
- Printing cost - estimated number of forms printed annually, multiplied by the unit cost of the forms.
  - Case processing cost - estimated number of forms completed, multiplied by a percentage of the unit cost of case processing.
  - Forms management cost - salary cost of forms management personnel.

Printing Cost	50,000 @	\$20.00/M	=	\$ 1,000.
Case Processing Cost	50,000	1.50/form	=	75,000.
Forms Management Cost			=	500.
Total Cost			\$	76,500.
