## Justification for:

PD F 2066, "Application by survivors for payment of bond or check issued under the Armed Forces Leave Act of 1946, as amended."

Veterans of WWII were issued bonds or checks as compensation fro leave accrued during the war. Survivors of a deceased veteran may apply for proceeds due the deceased.
