This is to let you know that I am forwarding your CC application for the signature of our Deputy Director. Your application has met the standards for issuance of a CC. The CC issuance date will be the day our Deputy Director signs your CC, and the CC will take effect on the issuance date or the date you begin to recruit participants, whichever is later. The CC paperwork should come soon by Fed-Ex, but the coverage will start from the issuance date, which I expect will be within the next two weeks.

If you have recruited people already, to comply with the regs, your participants should be notified (if they have not been notified already) in so far as it's feasible, about the CC coverage once your CC arrives. You could give them the revised consent form with CC information, or you could give them the CC information in some other form. People who were recruited before the CC takes effect still will be covered from the start of the study if they are participating in the study during the period of the CC—that is, even if they are not being interviewed anymore, but their data is on your rolls.
