CRIS is a Web Forms participating site.

Import / Export FY AD-419 data at CRIS

This function allows the CRIS site to import/export data to/from a comma-delimited file exported from a spreadsheet or tape format file submitted to CRIS on diskette or via FTP, whether or not the site is participating in the Web Forms, since many participating sites will not be using the AD-419 aspect, but will continue to use electronic submission methods they have been using in the past.
