GRAND TOTAL, LINE 399, should agree with totals on LINE 199 of SECTION 1 and totals on LINE 299 of SECTION 3.

**Columns 2, 4, 6, & 8. Domestic salt.**

Report the total quantity of each type of domestically produced salt used and/or sold for each use listed under CUSTOMER CLASSIFICATION. If the CUSTOMER CLASSIFICATION is not listed and/or not known, enter the quantity under OTHER. INCLUDE SALT PRODUCED BY THIS COMPANY AND/OR PURCHASED FROM OTHER DOMESTIC SALT COMPANIES. EXCLUDE SALT SOLD TO OTHER DOMESTIC SALT COMPANIES.

**Columns 3, 5, & 7. Imported salt.**

Report the total quantity of each type of imported salt used and/or sold for each use listed under CUSTOMER CLASSIFICATION. If the CUSTOMER CLASSIFICATION is not listed and/or not known, enter the quantity under OTHER. Exclude salt sold to other domestic companies.

*For example:*
