Justification for:

PD F 4000, " Request To Reissue United States Savings Bonds."

1. **Explain the circumstances that make the collection of information necessary. Identify any legal or administrative requirements that necessitate the collection.** Savings Bonds may be reissued upon the request of the owner or surviving registrant under certain authorized conditions.

2. **Indicate how, by whom, and for what purpose the information is to be used.** Used to identify the securities involved and to establish the authority to reissue them. Without the information, the transaction cannot be completed.

3. **Describe whether, and to what extent, the collection of information involves the use of automated, electronic, mechanical, or other technological collection techniques or other forms of information technology. What consideration is given to use information technology to reduce burden?**
Public Debt has been a leader in e-Gov, providing the public with options for conducting financial transactions online for several years. To provide our customers additional options for submitting information electronically, we are taking the following steps: a technical project team is exploring options (such as pay.gov) and will select the mechanism(s)/infrastructure needed; concurrently, reengineering of business processes (and forms) is being conducted as the result of a reorganization of our major business lines.

4. **Describe efforts to identify duplication. Why can't any similar information already available be used or modified for use for the purposes described in item 2 above?** Duplicate information is not requested.

8. **What effort was made to notify the general public about this collection of information?** The Bureau's notice was published in the Federal Register on December 11, 2006, Page 71611. No comments were received.

10. **What assurance of confidentiality was provided to respondents and what was the basis for the assurance in statute, regulations, or agency policy?** In accordance with the Privacy Act of 1974, information furnished by the public is assured confidentiality.

12. **What is the estimated hour burden of this collection of information?** The average time needed is 30 minutes per response multiplied by the estimated number of responses (540,000) reflects the total burden of 270,000 hours.
13. **What is the estimated total annual cost burden to respondents or recordkeepers resulting from this**

collection of information? Estimated cost burden to respondents is not available.

14. **What is the annualized cost to the Federal Government?** The following factors were used to estimate the annual burden to this agency:
- a. Printing cost - estimated number of forms printed annually, multiplied by the unit cost of the forms.
 - b. Case processing cost - estimated number of forms completed, multiplied by a percentage of the unit cost of case processing.
 - c. Forms management cost - salary cost of forms management personnel.

Case Processing Cost	540,000	1.50/form	=	810,000.
