## Justification for:

PD F 4000, "Request To Reissue United States Savings Bonds."

To provide our customers additional options for submitting information electronically, we are taking the following steps: a technical project team is exploring options (such as pay.gov) and will select the mechanism(s)/infrastructure needed; concurrently, reengineering of business processes (and forms) is being conducted as the result of a reorganization of our major business lines.

- 14. What is the annualized cost to the Federal Government? The following factors were used to estimate the annual burden to this agency:
  - a. Printing cost estimated number of forms printed annually, multiplied by the unit cost of the forms.
  - b. Case processing cost estimated number of forms completed, multiplied by a percentage of the unit cost of case processing.
  - c. Forms management cost salary cost of forms management personnel.

Printing Cost 540,000 @ \$20.00/M = \$10,800. Case Processing Cost 540,000 = \$10,000. Forms Management Cost = 500. Total Cost \$821,300.
