

## **SUPPORTING STATEMENT**

**Justification for:** PD F 4414, 4144-1, 4144-2, 4144-5, 4144-6, and 4144-7.

- 1. Explain the circumstances that make the collection of information necessary. Identify any legal or administrative requirements that necessitate the collection.** The information collected is essential for the establishment and maintenance of State and Local Government (SLG) security accounts. Requested information is used to issue a Statement of Account to the entity, calculate interest and to pay the redemption proceeds. (See Section 344.2 of Regulations Governing Securities of the State and Local Government Series.)
- 2. Indicate how, by whom, and for what purpose the information is to be used.** Used to establish State and Local Government Securities. Without the information, it would be impossible to establish SLG accounts.
- 3. Describe whether, and to what extent, the collection of information involves the use of automated, electronic, mechanical, or other technological collection techniques or other forms of information technology. What consideration is given to use information technology to reduce burden?**

Public Debt has been a leader in e-Gov, providing the public with options for conducting financial transactions online for several years. To provide our customers additional options for submitting information electronically, we are taking the following steps: a technical project team is exploring options (such as pay.gov) and will select the mechanism(s)/infrastructure needed; concurrently, reengineering of business processes (and forms) is being conducted as the result of a reorganization of our major business lines.

12. **What is the estimated hour burden of this collection of information?** The average time needed is 30 minutes per response multiplied by the estimated number of responses (5,000) reflects the total burden of 2,500 hours.

14. **What is the annualized cost to the Federal Government?** The following factors were used to estimate the annual burden to this agency:

- a. Printing cost - estimated number of forms printed annually, multiplied by the unit cost of the forms.
- b. Case processing cost - estimated number of forms completed, multiplied by a percentage of the unit cost of case processing.
- c. Forms management cost - salary cost of forms management personnel.
