

## **SUPPORTING STATEMENT**

### **Justification for:**

PD F 5394, " Agreement And Request For Disposition Of A Decedent's Treasury Securities."

1. **Explain the circumstances that make the collection of information necessary. Identify any legal or administrative requirements that necessitate the collection.** Treasury securities belonging to a deceased owner's estate may be distributed to the person(s) entitled to the estate when the estate was formally administered through the court and has been closed, or the estate is being settled in accordance with State statute without the necessity of the court appointing a legal representative.

2. **Indicate how, by whom, and for what purpose the information is to be used.** Used to identify the securities involved and to establish the person(s) entitled. Without the information, the transaction cannot be completed.

3. **Describe whether, and to what extent, the collection of information involves the use of automated, electronic, mechanical, or other technological collection techniques or other forms of information technology. What consideration is given to use information technology to reduce burden?**

Public Debt has been a leader in e-Gov, providing the public with options for conducting financial transactions online for several years. To provide our customers additional options for submitting information electronically, we are taking the following steps: a technical project team is exploring options (such as pay.gov) and will select the mechanism(s)/infrastructure needed; concurrently, reengineering of business processes (and forms) is being conducted as the result of a reorganization of our major business lines.

modified for use for the purposes described in item 2 above? Duplicate information is not requested.

The collection of information cannot be conducted less frequently because the collection is initiated for a single purpose.
8. **What effort was made to notify the general public about this collection of information?** The Bureau's notice was published in the Federal Register on January 9, 2007, Page 1058. No comments were received.

10. **What assurance of confidentiality was provided to respondents and what was the basis for the assurance in statute, regulations, or agency policy?** In accordance with the Privacy Act of 1974, information furnished by the public is assured confidentiality.

12. **What is the estimated hour burden of this collection of information?** The average time needed is 30 minutes per response multiplied by the estimated number of responses (4,100) reflects the total burden of 2,050 hours.

14. **What is the annualized cost to the Federal Government?** The following factors were used to estimate the annual burden to this agency:
- a. Printing cost - estimated number of forms printed annually, multiplied by the unit cost of the forms.
  - b. Case processing cost - estimated number of forms completed, multiplied by a percentage of the unit cost of case processing.
  - c. Forms management cost - salary cost of forms management personnel.
