## Justification for:

PD F 5377, "U.S. Treasury Securities State And Local Government Series Early Redemption Request."

Identify any legal or administrative requirements that necessitate the collection. 31 CFR Part 344 authorizes the Secretary of the Treasury to prescribe the terms and conditions of the sale of U.S. Treasury Securities State and Local Government Series.
- 2. Indicate how, by whom, and for what purpose the information is to be used. Used to identify the securities involved and to request early redemption. Without the information, the transaction cannot be completed.
- 3. Public Debt has been a leader in e-Gov, providing the public with options for conducting financial transactions online for several years. - 14. What is the annualized cost to the Federal Government? The following factors were used to estimate the annual burden to this agency:
  - a. Printing cost estimated number of forms printed annually, multiplied by the unit cost of the forms.
  - b. Case processing cost estimated number of forms completed, multiplied by a percentage of the unit cost of case processing.
  - c. Forms management cost salary cost of forms management personnel.

Printing Cost 494 @ \$.05 each = \$ 24.70 Case Processing Cost 494 1.50/form = 741.00Forms Management Cost = 500.00Total Cost \$ 1265.70
