- US-AID and FAS if the Request is currently at their processing site.
- Sponsors, PDD, EOD, and BCD, as Commodity Request Originator if the Request is currently at the Originator's processing site.

- **Commodity** - Replacement Commodity selection is restricted to Commodities approved for the program on the Request Header.

- Use the **Select** check box to select a single or multiple preferable Commodities from the Table.

- **Country** - Displays the Country funding the Commodity Delivery.

- **Delivery Point** - Displays the Destination Country (point of delivery) where the Steamship Line relinquishes possession of the Commodity.

- Only the Substitutables that match the program type are displayed in the Table.
- **Select** - At least one Substitutable Commodity must be selected from the Substitutable Commodity Table.
