This report is authorized by Section 11 (d) of the Fair Labor Standards Act. Completion of the form is voluntary. However, failure to provide the information will result in non-issuance of a homeworker certificate and such employment will be in violation of Section 11 (d) of the Fair Labor Standards Act.
