This filing requirement applies to the years beginning after December 31, 2006 - so if the organization was active and had average gross receipts of \$25,000 or less over the last 3 years, then it would have to file 990-N. In addition, any required organizations that do not file the notice for 3 consecutive years will lose their tax-exempt status.
