Our firm of which engaged in the manufacture of Citrus products, hereby requests the Texas Valley Citrus Committee to approve this application for eligibility of Sections 906.34 and 906.40 of Marketing Order 906.

In submitting this application, the undersigned organization understands that all Texas citrus our firm receives that is exempt from regulations, must be used solely for the purpose of processing of juice products. Our firm agrees:

1. That such citrus received for processing purposes will under no circumstances enter into the fresh fruit marketing channels.
2. Not to sell or transfer for sale, directly or indirectly, any fruit from Texas for processing.
3. To maintain its PACA license during the period when buying fruit from Texas.
4. To undergo random inspection by the Committee or by a designated State/Federal Agency.
5. To not having facilities, equipment, or outlet to repack or sell fruit in fresh form.
6. To report to the Texas Valley Citrus Committee on the "Orange and Grapefruit Diversion Report" as provided by the Handler from whom the fruit is purchased, the actual weight of the fruit by attaching the scale ticket at point of receiving to the proper copy of the Diversion Report. **This shall be returned to the Committee within the week.**
7. We understand that failure to comply with the terms of this agreement, will cause removal of our name from the list of certified processors.

This agreement when signed by an authorized agent and returned to the Committee, will serve as certification as a receiver of Texas citrus for processing into juice products.
