- Received more than \$6,000 or exceeded time – Students who were no longer eligible to receive scholarship funds in the final semester or quarter(s) of the report year because they exceeded the maximum time or funds (exclude graduates). Students may receive scholarship funds for a maximum of four years or receive up to \$6,000.

**Section 5** – Students No Longer Financially Eligible:

Provide the number of students who received the full \$1500 scholarship, but will no longer be eligible to receive a scholarship in the next report period due to receiving more than \$6,000 or have exceeded the four-year maximum scholarship term (exclude graduates).
