In consideration of the approval of this application, undersigned agrees that all almond material acquired from almond handlers or growers will be used only for the purposes indicated, that none will be disposed of for human consumption and that Board employees may enter applicant's premises at any reasonable time to observe the storage or disposition of the almond material, and to examine and audit all books and records necessary to substantiate compliance with quality control provisions governing inedible dispositions. Undersigned also agrees to obtain from each almond handler an executed ABC Form 8, on each lot of material received, and upon crushing, mixing or feeding the almonds, to execute part (b) of the form and mail it promptly to the Board. Undersigned also agrees to furnish to the Board a public weighmaster certificate substantiating the weight of the inedible material received applicable to each Form 8. The weight tag will be issued at time of receipt, in the name of the undersigned. Undersigned also agrees to complete and submit an accepted user data sheet as part of the Board's annual process of granting accepted user status. Undersigned also acknowledges that accepted user status is subject to revocation at any time by the Board for cause.

Undersigned hereby certifies to the U.S. Department of Agriculture and to the Almond Board that the information supplied herein is complete and correct and that the above agreement as to usage and reporting is accepted.

Note: The making of any false statement or representation on this form, knowing it to be false, is a violation of Title 18, Section 1001, United States Code, which provides for the penalty of a fine of \$10,000 or imprisonment of not more than five years, or both.
