The information collection was previously published in the Federal Register on April 9, 2007, at 72 FR 17576. The notice allowed for a 60-day public comment period. No comments were received on this information collection.

The purpose of this notice is to allow an additional 30 days for public comments. Comments are encouraged and will be accepted until July 25, 2007. This process is conducted in accordance with 5 CFR 1320.10.

(1) Evaluate whether the collection of information is necessary for the proper performance of the functions of the agency, including whether the information will have practical utility;

(2) Evaluate the accuracy of the agencies estimate of the burden of the collection of information, including the validity of the methodology and assumptions used;

(3) Enhance the quality, utility, and clarity of the information to be collected; and

(4) Minimize the burden of the collection of information on those

who are to respond, including through the use of appropriate automated, electronic, mechanical, or other technological collection techniques or other forms of information technology, e.g., permitting electronic submission of responses.

Overview of this information collection:

(1) Type of Information Collection: Revision of an existing information collection.

(2) Title of the Form/Collection: Petition for Amerasian, Widow, or Special Immigrant.

(5) An estimate of the total number of respondents and the amount of time estimated for an average respondent to respond: 13,684 responses at 2 hours per response.

(6) An estimate of the total public burden (in hours) associated with the collection: 27,368 annual burden hours.
