The "United States of America, acting through the Rural Housing Service or its successor agency," must be shown in either a mortgage clause or on the declaration page in the order of priority of their mortgage. Written evidence that the following systems are functioning properly and meet all Rural Development requirements must be submitted to Rural Development before loan closing or to the closing agent at loan closing:
