# Justification statement for Help America Vote Act (HAVA) Voting Access Annual Report 0970-XXXX

#### A. Justification

# 1. <u>Circumstances that make the collection of information</u> <u>necessary</u>

Public Law 107-252, Help America Vote Act of 2002, section 265 (42 USC 15425) requires a report not later than 6 months after the end of each fiscal year for which an eligible state or unit of local government received payment under this part, the State or unit shall submit a report to the Secretary on the activities conducted with the funds provided during the year, and shall include in the report a list of expenditures made with respect to each category of activities described in section 261(b).

A copy of section 265 (42 USC 15425) is attached and noted as page 36.

#### 2. <u>Use of information</u>

Each State or Unit of Local Government that receives funding must prepare and submit an annual report at the end of every fiscal The report addresses the activities conducted with the vear. funds provided during the year. The information collected from the annual report will be aggregated into an annual profile of how States have utilized the funds and establish best practices for election officials. It will also provide an overview of the State election goals and accomplishments and permit the Administration on Developmental Disabilities to track progress of voting accessibility to monitor grant activities.

## 3. <u>Use of information technology</u>

The Administration on Developmental Disabilities (ADD) has no funding under the Developmental Disabilities (DD) Act to support an electronic reporting system for the Help America Vote Act (HAVA) Voting Access Annual Report.

## 4. <u>Efforts to identify duplication</u>

There have not been any formal efforts to identify duplication

because there are no similar programs collecting information regarding the Help America Vote Act (HAVA) program.

# 5. <u>Information collection involving small businesses</u>

The information collected does not involve, nor result in assignment of burden to any small business. It is collected from 55 designated states and units of local government.

# 6. <u>Consequence to Federal program or policy activities if</u> <u>collection is conducted less frequently</u>

No accountability of how HAVA funds are being used

# 7. Special circumstances

There are no special circumstances governing the collection of data.

# 8. <u>Outside consultation regarding availability of data</u>

The report format has been suggested to the States and units of local government since fiscal year 2003. The format is based on the four (4) mandated areas of activities authorized under 42 USC 15421 of the Help America Vote Act.

A 60 day comment period was provided. The solicitation of comments for the proposed information was published in the Federal register, volume 72, number 8, page 1538 (January 12, 2007). Only one 1 comment received during the 60 days. The comment is as follow:

<u>Comment:</u> "I do not believe this program is effective or accomplishing anything at all. Therefore, I think the program should be shut down and tax dollars saved therefore. I also would like a copy of the final report from 2005 showing what accomplishments are claimed with the spending of the tax dollars for this program."

Action: No action taken on this comment.

Another 60 day comment period was provided. The solicitation of comments for the proposed information was published in the Federal register, volume 72, number 34, page 7888-7889 (February 21, 2007). No comments received during the 60 days or anytime thereafter.

A 30 day comment period was provided. The solicitation of comments for the proposed information collection was published in the Federal Register, volume 72, number 73, page 19936. Only one (1) comment received during the 60 days. The comment is as follow:

<u>Comment:</u> "Please send an electronic copy of the proposed data collection form to <u>matt.hayden@ndrn.org</u> so that we may comment on this item."

<u>Action:</u> A copy of the Help America Vote Act (HAVA) annual narrative report form e-mailed on 5/2/2007.
