## **Authorizing Legislation:**

The survey of the commercial sector is authorized under the Federal Energy Administration Act of 1974; Public Law 93-275, as amended, and the Energy Policy Act of 1992 (Public Law 102-486). The Commercial Buildings Energy Consumption Survey (CBECS), conducted by the Energy Information Administration of the U.S. Department of Energy, is a voluntary survey that provides information about energy use in U.S. buildings.

## Respondent Confidentiality:

This survey will be conducted under the Confidential Information Protection and Statistical Efficiency Act (CIPSEA) of 2002 (P.L. 107-347). Data collected under the provisions of this legislation are required to be kept confidential and to be used only for statistical purposes (i.e., characterizations for population subgroups that do not reveal any information that could identify individual responses). The Energy Information Administration, as the sponsoring organization for the CBECS, is responsible for assuring that all identifying information such as respondent names and addresses and/or building names and addresses are kept confidential and cannot be linked to the data collected in the CBECS.
