2007 Form 8453
U.S. Individual Income Tax Transmittal
for an IRS *e-file* Return

The Title has been changed. We have replaced 'Declaration' with 'Transmittal'. ETA

The phone number entry space has been removed from the identifying section of the form. ETA

We have removed all of Parts I, II, and III. ETA

We have inserted a series of check boxes and new text describing the anticipated attachments.

On Friday, June 29, a TPCC meeting was held to consider a change of the form number. A decision was made to retain the current form number, in part, because it is anticipated the form will be discontinued within 2-4 years. The purpose of the form has also changed from being a declaration (with signature) document to a transmittal (without signature) document. The revised form will only be used to transmit those forms and documents that cannot be electronically filed with a return and are reflected on the form.

General Instructions

Purpose of Form

Use Form 8453 to send any required paper forms or supporting documentation listed next to the checkboxes on Form 8453 (do not send Forms W-2, W-2G, or 1099-R).

Note. Do not mail a copy of an electronically filed Form 1040, 1040A, or 1040EZ to the Internal Revenue Service (IRS).

When and Where To File

The ERO must mail Form 8453 to the IRS within 3 business days after receiving acknowledgement that the IRS has accepted the electronically filed tax return. Mail Form 8453 to the IRS at the applicable address shown in the chart below.

Line Instructions

Declaration control number (DCN). The DCN is a 14-digit number assigned by the ERO to each tax return. Clearly print or type the DCN in the top left corner of each Form 8453 after the IRS has acknowledged receipt of the electronic tax return. The first two digits are the file identification number and are always "00". The next six digits are the electronic filer identification number (EFIN) assigned by the IRS. The next three digits are

the batch number (000 to 999) assigned by the ERO. The next two digits are the serial number (00 to 99) assigned by the ERO. The last digit is the year digit (for returns filed in 2008, the year digit is "8").

Example. The EFIN is 509325. The batch number is 000. The serial number is 56. The DCN is 00-509325-00056-8.

Name and address. If the taxpayer received a peel-off name and address label from the IRS, put the label in the name area. Cross out any incorrect information and print the correct information. Add any missing items, such as your apartment number. If the taxpayer did not receive a label, print or type the information in the spaces provided.

P.O. box. Enter the box number only if the post office does not deliver mail to the taxpayer's home.

Note. The address must match the address shown on the electronically filed tax return.

Social security number (SSN). Be sure to enter the taxpayer's SSN in the space provided on Form 8453. If a joint tax return, list the SSNs in the same order as the first names.



Do not attach any form or document that is not shown on Form 8453 next to the checkboxes. If you are required to mail in any documentation not listed on Form 8453, you cannot file your tax return electronically.

Paperwork Reduction Act Notice. We ask for the information on this form to carry out the Internal Revenue laws of the United States. You are required to give us the information. We need it to ensure that you are complying with these laws and to allow us to figure and collect the right amount of tax.

You are not required to provide the information requested on a form that is subject to the Paperwork Reduction Act unless the form displays a valid OMB control number. Books or records relating to a form or its instructions must be retained as long as their contents may become material in the administration of any Internal Revenue law. Generally, tax returns and return information are confidential, as required by Internal Revenue Code section 6103.

The average time and expenses required to complete and file this form will vary depending on individual circumstances. For the estimated averages, see the instructions for your income tax return.
