

### **Non-significant Changes to Form I-693**

The USCIS is changing the Form I-693 as follows:

1. The current vaccination Supplement A has been moved under Part 2 of the form to make it easier to have all of the medical examination questions under one part. The content remains the same.
2. According to 42 CFR 34.3(b)(2)(i) (see below) the tuberculin skin test is required for applicants age 2 years and older, instead of the previous requirement of 6 months and older. Accordingly, the Form and Instructions have been changed to 2 years instead of 6 months. Based on USCIS experience with this program it is estimated that the number of children affected by this change will be minimal and will not require a change in the burden hours for this information collection.
3. Cosmetic changes have been made to include format changes. For example, on page 1 of the instructions, there were two boxes titled, "The instructions on this form are organized as follows:" and "Notice." These two sections have been removed.

Shading of new section titles has also been added to enhance readability.

#### **42 CFR 34.3 Scope of examinations.**

\* \* \* \* \*

*(b) Persons subject to requirement for chest X-ray examination and serologic testing.*

*(2) Tuberculin skin test examination. (i) All aliens 2 years of age or older in the United States who apply for adjustment of status to permanent residents, under the immigration laws and regulations, or other aliens in the United States who are required by the INS to have a medical examination in connection with a determination of their admissibility, shall be required to have a tuberculin skin test. Exceptions to this requirement may be authorized for good cause upon application approved by the Director. In the event of a positive tuberculin reaction, a chest X-ray examination shall be required. If the chest radiograph is consistent with tuberculosis, the alien shall be referred to the local health*

authority for evaluation. Evidence of this evaluation shall be provided to the civil surgeon before a medical notification may be issued.

(ii) Aliens less than 2 years old shall be required to have a tuberculin skin test if there is evidence of contact with a person known to have tuberculosis or other reason to suspect tuberculosis. In the event of a positive tuberculin reaction, a chest X-ray examination shall be required. If the chest radiograph is consistent with tuberculosis, the alien shall be referred to the local health authority for evaluation. Evidence of this evaluation shall be provided to the civil surgeon before a medical notification may be issued.
