8. Number of official samples inspected.
9. Total number of hundredweights for inspections, when applicable. This does not include submitted sample inspections.
10. Number of appeal inspections.
11. Enter total inspections for each category. Note: DSCP means Defense Supply Center Philadelphia and is used for military contracts.
12. Enter total numbers of tests performed plus cwt if applicable. For export, each subplot is a test. The field office or cooperator performing the test should enter the data.
