## The National Recreational Boating Survey

This telephone survey targets all boating households<sup>1</sup> whether they own a recreational vessel or not. It collects data about registered and unregistered recreational vessels, and is to be conducted only in states where mailing lists of registered boat owners are not available for a state wide mail survey.
