**REFERENCE PERIOD**

Complete this form monthly for the pay period that includes the 12<sup>th</sup> day of the month. If you have a weekly or biweekly pay period and the 12<sup>th</sup> falls on a Saturday, report for the period ending on the 12<sup>th</sup>. If the 12<sup>th</sup> falls on a Sunday, report for the pay period starting on the 12<sup>th</sup>.

**WOMEN EMPLOYEE COUNT (Column 2)**

Number of employees from column 1 who are women.

**EMPLOYEE COUNT (Column 1)**

Enter the total number of persons who worked or received pay for any part of the pay period including the 12<sup>th</sup> of the month.

**Include:**

- Elected or appointed officials
- Full-time or part-time workers
- Trainees
- Workers on paid vacation
- Workers on paid sick leave
- Workers on other paid leave
- Workers on active duty, if receiving pay from employer

**Exclude:**

- Institution inmates
- Outside contractors and their workers
- Pensioners
