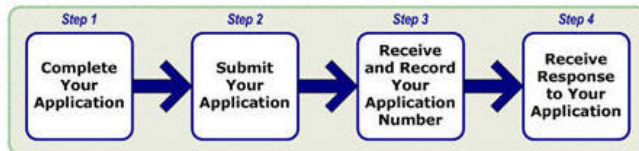

Disclaimer

The Electronic System for Travel Authorization performs checks against the United States Government databases. All travelers seeking admission to the United States under the Visa Waiver Program (VWP) are required to obtain an electronic travel authorization prior to being granted boarding.

If your electronic travel authorization is approved, it establishes that you are eligible to travel, but does not guarantee that you are admissible to the United States. Upon arrival to the United States, you will be inspected by a Customs and Border Protection (CBP) officer at a port of entry who may determine that you are inadmissible under the VWP or for any reason under United States law.

A determination that you are not eligible for electronic travel authorization does not preclude you from applying for a visa.

All information provided by you, or on your behalf by a designated third party, must be true and correct. An electronic travel authorization may be revoked at any time and for any reason, such as new information influencing eligibility. You may be subject to administrative or criminal penalties if you knowingly and willfully make a materially false, fictitious, or fraudulent statement or representation in an electronic travel authorization application submitted by you or on your behalf.

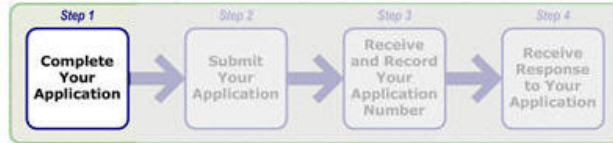
