Note to interviewer: When the participant is finished, help them take off the head phones and move the computer to the side.

Debriefing interview

Ok, now I'd like to ask you some questions about your experience answering the questions on the computer, how you understood certain questions, interpreted certain words, and whether any of the questions were difficult to answer, and how you think we could change the questions so more people will understand them. We are NOT interested in your answers to the questions.

Note to Reviewers:

The interviewer will ask emergent probes to better understand the respondent's experience using the headphone/computer set-up as well as the question-response process. Examples of the sorts of probes that may be asked at the interviewer's discretion include:

- First, did you have any problems using the computer to answer the questions?
- Did using the computer with headphones allow you to feel like you could answer the questions honestly?
- Did any of the sections seem particularly sensitive or embarrassing to you? Did it make you feel like not answering the questions? Which section would you say is the most sensitive? The least sensitive?
- Do you think there might be a problem asking these kinds of questions— questions that might potentially embarrass people?
- Could you tell me what [term] means to you?
- In your own words, could you tell me what you think this question is asking?
- How difficult was it for you to think of your answer to this question? Can you tell me more about that?
- How sure are you about your answer?
- Can you tell me anything about [question] that made it hard to understand or to answer accurately?

Ending the interview

In looking at my watch, we are pretty much out of time. Do you have any last thoughts or questions? [If not, proceed]. [Continue recording] I want to thank you for coming today and sharing your thoughts, experiences, and opinions. The information you have provided will be very useful in helping to improve the questionnaire. [Hand the respondent the packet containing the thank-you letter, copy of consent form, and the \$40]. In this packet you'll see we have provided you with a copy of the consent form you read prior to the start of our interview. This is for your records [point to consent form]. We have also included a thank-you letter signed by the Director of the National Center for Health Statistics along with the \$40 cash incentive we promised [point to thank you letter and envelope containing \$40]. Again, thank you for all of your assistance today. [Turn off audio tape recorder at this time]. [Escort respondent out of the interviewing room].
