

SUPPORTING STATEMENT
FOR PAPERWORK REDUCTION ACT SUBMISSION

A. Justification

1. Explain the circumstances that make the collection of information necessary. Identify any legal or administrative requirements that necessitate the collection. Attach a copy of the appropriate section of each statute and regulation mandating or authorizing the collection of information.

Consistent with the provisions of P.L. 105-244 (Title VII, Part B, Section 741 of the Higher Education Act as amended), the Fund for the Improvement of Postsecondary Education (FIPSE) works to improve postsecondary education through grants to postsecondary educational institutions and agencies. Such grants are awarded on the basis of competitively reviewed applications submitted to FIPSE under its Comprehensive and Special Focus Competition Program grant competitions (see P.L. 105-244 [Title VII, Part B, Section 744(c)(3) and (4)] for Special Focus Competitions). The U.S. Department of Education is requesting approval of the grant application guidelines used to solicit applications for new grants under the Special Focus Program: the U.S.-Russian Program: Improving Research and Educational Activities in Higher Education (U.S.-Russia Program). This is a new Special Focus Competition under FIPSE. The U.S.-Russia Program is an outgrowth of a Memorandum of Understanding (MOU) signed on May 31, 2006 between the U.S. Department of Education and the Russian Ministry of Education and Science. The MOU supports the promotion of understanding between the peoples of the Russian Federation (RF) and the United States (U.S.) and improving the quality of their human resource development. It is the intent of the U.S. Department of Education and the Russian Ministry to conduct the first competition for the U.S.-Russia Program in fiscal year 2007. The request and justification provided here applies to the applications instruction package, which includes program-specific forms for the U.S.-Russia competition as well as other information required for submissions through the electronic portal, "Grants.gov."

FIPSE's U.S.-Russia Program awards grants to U.S. institutions participating in bilateral institutional cooperation to support innovative projects that will improve research and education activities in higher education in the U.S. and Russia. The rationale for the U.S.-Russia Program is based upon the growing pace of global interconnectedness, which is requiring

postsecondary education to prepare individuals for work that will be in an international environment. Institutions are funded by their respective government agencies: in the United States, the U.S. Department of Education's Fund for the Improvement of Postsecondary Education (FIPSE); in Russia, the Russian Ministry of Education and Science.

2. Indicate how, by whom, and for what purpose the information is to be used. Except for a new collection, indicate the actual use the agency has made of the information received from the current collection.

The application guidelines for the U.S.-Russia Program were used for the first time in fiscal year 2007. The guidelines have been developed in cooperation with the Russian Ministry of Education and Science. The guidelines are used to provide institutions of higher education with information and criteria by which they can submit proposals to the U.S.-Russia grant competition.

The U.S.-Russia Program awards grants to U.S. institutions that form a bilateral consortium with institutions in Russia. At least one institution from the U.S. and one institution from the Russian Federation comprise a collaborative study program. Collaborative study programs or consortia also may involve more institutions in the U.S. and Russia. It is recommended that no more than six institutions comprise a consortium or collaborative study program (i.e., three institutions from the U.S. and three institutions from the Russian Federation.) For each country, one institution is designated as the lead institution or fiscal representative responsible for submitting a proposal to its respective government. Using established review criteria in 34 CFR 75, external readers and FIPSE program staff review the U.S. applications. Five applications were received for the first competition in FY 2007 and it is anticipated that 10-12 applications will be received in FY 2008 and in subsequent years. For fiscal year 2007, 3 applications were funded. Funded applications received awards totaling no more than \$400,000 for a two-year period. The first year of funding ranged from \$158,000 - \$217,000 in FY 2007.

3. Describe whether, and to what extent, the collection of information involves the use of automated, electronic, mechanical, or other technological collection techniques or forms of information technology, e.g. permitting electronic submission of responses, and the basis for the decision of adopting this means of collection. Also describe any consideration of using information technology to reduce burden.

The U.S. Department of Education's Office of Postsecondary Education (OPE) is now using the electronic portal "Grants.gov" to receive grant applications.

Fiscal Year 2006 was the first year that many grant competitions within OPE used this portal. Submission through "Grants.gov" will be the method by which applications are received in the U.S.-Russia Program.

As a result of efforts to streamline electronic submission for FIPSE's Special Focus Programs – all of which currently are international programs, (i.e., the U.S.-Brazil Program, the North American Program, and the E.U.-U.S.-Atlantis Program), the Title Page, Budget Form, and Consortia Identification Partner Form) were consolidated for use within "Grants.gov " in Fiscal Year 2006. The consolidated forms have an OMB expiration date of January 31, 2009. However, procedures within "Grants.gov have changed for fiscal year 2007. Therefore, these forms will no longer be consolidated forms that require Pure Edge software for use in "Grants.gov." They are part of the application package for the U.S.-Russia Program, which means that they were used by applicants as Word documents and then uploaded into "Grants.gov" as attachments to the applications package. The information on the forms has not changed but the procedure for using them has (i.e., "Grants.gov" no longer uses Pure Edge software). For the U.S.-Russia Program, the three forms are included as part of the U.S.-Russia application package to OMB.

4. Describe efforts to identify duplication. Show specifically why any similar information already available cannot be used or modified for use of the purposes described in Item 2 above.

FIPSE staff has made every effort to ensure that there is no duplication of data acquisition. The collection is unique to the collaborative postsecondary efforts between the United States and Russia through the respective governmental programs: FIPSE and the Russian Ministry of Education and Science.

5. If the collection of information impacts small businesses or other small entities (Item 5 of OMB Form 83-I), describe any methods used to minimize burden.

The collection of information does not impact small businesses or other small entities.

6. Describe the consequences to Federal program or policy activities if the collection is not conducted or is conducted less frequently, as well as any technical or legal obstacles to reducing burden.

This application process occurs on an occasional basis (less than once a year) to enable applicants to compete for Federal funds that are appropriated by Congress. This application is the lowest frequency possible to award funds appropriated for this purpose.

7. Explain any special circumstances that would cause an information collection to be conducted in a manner:

- requiring respondents to report information to the agency more often than quarterly;
- requiring respondents to prepare a written response to a collection of information in fewer than 30 days after receipt of it;
- requiring respondents to submit more than an original and two copies of any document;
- requiring respondents to retain records, other than health, medical, government contract, grant-in-aid, or tax records for more than three years;
- in connection with a statistical survey, that is not designed to produce valid and reliable results than can be generalized to the universe of study;
- requiring the use of a statistical data classification that has not been reviewed and approved by OMB;
- that includes a pledge of confidentiality that is not supported by authority established in statute or regulation, that is not supported by disclosure and data security policies that are consistent with the pledge, or which unnecessarily impedes sharing of data with other agencies for compatible confidential use; or
- requiring respondents to submit proprietary trade secrets, or other confidential information unless the agency can demonstrate that it has instituted procedures to protect the information's confidentiality to the extent permitted by law.

Please note that no special circumstances apply to the circumstances cited.

8. The U.S. Department of Education does not provide any payment or gift to respondents.

10. Describe any assurance of confidentiality provided to respondents and the basis for the assurance in statute, regulation, or agency policy.

No assurance of confidentiality is provided to respondents except as provided by the Privacy Act and the U.S. Department of Education's policies governing the review of discretionary grant applications.

Number of Respondents: 12

Frequency of response: once annually

Annual hour burden: 30 hours per applications; total 360 annual hour burden. Annual hour burden was estimated based on oral accounts of applicants and grantees from similar FIPSE international programs that have occurred over the years.

Estimated Annualized Cost to Respondents of Hour Burdens:

These estimates are based on the U.S. - Russia competition conducted in FY 2007 and other special focus competitions conducted in previous years by the Fund for the Improvement of Postsecondary Education. OPE evaluated the accuracy of the burden estimates and the estimates above seem to be the best estimate.

13. Provide an estimate of the total annual cost burden to respondents or record keepers resulting from the collection of information. (Do not include the cost of any hour burden shown in Items 12 and 14.)

The cost estimate should be split into two components: (a) a total capital and start-up cost component (annualized over its expected useful life); and (b) a total operation and maintenance and purchase of services component. The estimates should take into account costs associated
