Raisins - Section 8e Certification of Processor or Reseller

Section 8e (14) (A) of the Agricultural Marketing Agreement Act of 1937, provides that any person who violates the provisions of Section 8e, may be fined not less than \$50 or more than \$5,000 for each such violation. Each day that such violation continues shall be deemed a separate violation.
