Instructions for Completing Form SSA-8202-OCR-SM-FS

Why We're Sending You The Enclosed Form

We must regularly review the cases of people who get Supplemental Security Income (SSI). We check to be sure that each person is still eligible and we are sending the right amount of SSI money.

As part of your review, we need you to answer the questions on the enclosed form. It's called Statement For Determining Continuing Eligibility for Supplemental Security Income Payments. SSA-8202-OCR. If you have a representative payee (that's someone w) receives your SSI payment for you), he or she must complete the form.

Below, we'll tell you how to complete the form and what to do if you nee help. In the other booklet, we'll also go over some other important facts We'll explain:

- Changes you need to report to us.
- Computer matching, transfer of resources, Medicaid, and food stamp

**How to Complete** Form SSA-8202-OCR

Here are some things to remember when you are completing the SSA-8202-OCR.

- Use a black ink pen or #2 pencil.
- Please answer all the questions with one exception. DO NOT ANSW question 12 if you live in:

#### How to Complete Form SSA-8202-OCR (continued)

- Answer "YES" or "NO" questions by marking an "X" inside the "YES" or "NO" boxes.
- Sign your name in the space marked Your Signature. Your spouse signs in the space marked Husband's or Wife's Signature if both of you get SSI checks.
- If you are completing the form because you are a representative payee, sign your name in the representative payee space.
- Check the address that we have for you. If it's wrong, let us know.
- If you are completing the form for a child, answer questions as if the child were completing the form.

### When to Return The SSA 8202-OCR

Please return your completed form to us in the enclosed envelope within 30 days from the date you receive the form.

#### If We Don't Hear From You

Your SSI payments will stop if:

Before we stop payments, we will send you a letter. The letter explains our action and what to do if you think we are wrong.
