**SPECIFIC INSTRUCTIONS**

**1. Self-explanatory.**

**2. Gypsum sold or used during year.**

**Crude gypsum mined in the United States.**

Include gypsite and anhydrite.

**Calcined gypsum.**

Include gypsum produced from domestic, imported, or byproduct crude material, exclusive of additives.

**Byproduct gypsum.**

Include gypsum from fertilizer plants, other chemical plants, and thermal powerplant scrubber operations.

**COLUMN (2) Quantity.**

Report in short tons the quantity of gypsum sold or used during year.

**COLUMN (3) Value.**

Report the net selling value f.o.b. your establishment for the quantity in COLUMN (2). Report the total value received after discounts and allowances and excluding container cost, where applicable. If you consumed material in your establishment or shipped it to another establishment of your company, please estimate the value for this material.

**3. Gypsum products sold or used during year.**

Report all tonnages in short tons. DO NOT REPORT DECIMALS OR FRACTIONS. Exclude gypsum products or materials transferred from one gypsum plant to another gypsum plant of the same company. Include gypsum products, whether sold or transferred for use in the manufacture of non-gypsum products, such as cement. **Bagged goods.**

**Mill-mixed base coat.**

Include with regular plasters.

**Veneer plaster.**

Include base coat and finish plasters, and all other gypsum prepared finishes.

### (c) BOARD PRODUCTS.

Report board products, except laminated board, on a surface area basis, regardless of thickness. Report the surface area of the components of laminated board, rather than the finished product. Report the net selling value f.o.b. your establishment for the quantity reported. Report the total value received after discounts and allowances and excluding container cost, where applicable.

#### **Lath.**

Include regular, type X, perforated, foil back, including non-standard widths and lengths, EXCLUDE bases for veneer plasters.

#### **Veneer base.**

Include gypsumboard used as base for veneer plasters.

#### **Sheathing.**

Include all single thickness sheathing including type X board with or without water-resistant treatment.

#### **Regular gypsumboard.**

Include all thicknesses regular core board, form board, backer board, water-resistant board. Report footage of laminated products based on area of component parts and not of finished product; EXCLUDE all type X core, predecorated products, and 5/16 inch mobile home board.

#### **Type X gypsumboard.**

Same as "Regular gypsumboard," except all type X core; EXCLUDE all regular core, gypsum sheathing and predecorated products.

#### **Predecorated wallboard.**

Include all products on which a decorative surface is factory applied; laminated or adhered to base products regardless of core, thickness or type. EXCLUDE all 5/16 inch predecorated products and foil-back unless sold for decorative purposes.

#### **5/16 inch mobile home board.**

Include all 5/16 inch board regardless of predecorated or plain surface.
