B. Collections of Information Employing Statistical Methods.

1. Describe (including numerical estimate) the potential respondent universe and any sampling or other respondent selection method to be used. Data on the number of entities (e.g., establishments, State and local government units, households, or persons) in the universe covered by the collection and in the corresponding sample are to be provided in tabular form for the universe as a whole and for each of the strata in the proposed sample. Indicate expected response rates for the collection as a whole. If the collection has been conducted previously, include the actual response rate achieved during the last collection.

The potential respondent pool for the CAPTAP survey includes Federal, State, and local government employees and associated government contractors who attend a CAPTAP training session and whose duties include homeland security responsibilities for collecting and assessing critical infrastructure and key resource (CIKR) data and supporting the development of CIKR protection programs in their respective jurisdictions. Participants volunteer to participate in this program. The total population size of this group is not currently known.

This survey is administered after every training session to CAPTAP participants who voluntarily take the survey. The survey is a census of all participants who attend training and does not use sampling or other demographic targeting techniques.

Based on past training sessions, we expect that about 400 unique participants will attend CAPTAP training per year. Multiple sessions are offered per month and the number of participants at each session varies. Survey administration occurs at the conclusion of each survey session. CAPTAP employs several instructors, so receiving responses from each session helps the C/ACAMS Program Management Office gauge instructor performance in addition to evaluating the training program.

Past experience in collecting data from CAPTAP sessions leads us to expect response rates of between 75 and 100 percent per session, factoring in the potential for refusals. Similarly, we expect an overall response rate of between 75 and 100 percent.

2. Describe the procedures for the collection of information including:

• Statistical methodology for stratification and sample selection,

The CAPTAP survey is a census of all training participants and does not use sampling or stratification.

• Estimation procedure,

The data collected will be representative of only those that have attended training, and analysis will not attempt to generalize the data to a larger population.

• Degree of accuracy needed for the purpose described in the justification,

No specific degree of accuracy is needed, however high response rates will ensure greater validity of the results and applicability to the CAPTAP and C/ACAMS program.

• Unusual problems requiring specialized sampling procedures, and

This survey requires no specialized sampling procedures.

Any use of periodic (less frequent than annual) data collection cycles to reduce burden.

CAPTAP training participants will attend only one training session and complete only one survey before becoming regular users of the C/ACAMS tool.

3. Describe methods to maximize response rates and to deal with issues of non-response. The accuracy and reliability of information collected must be shown to be adequate for intended uses. For collections based on sampling, a special justification must be provided for any collection that will not yield "reliable" data that can be generalized to the universe studied.

The CAPTAP survey is self-administered and is provided as a Web link at the conclusion of the instructor-led training sessions to all training participants. Training is done in part using a computer, so participants have ready access to the Web to respond to the survey. This method of administration helps to maximize response while minimizing non-response bias. If the person chooses not to participate, no constraints are imposed and they are considered to have completed the training without participating in the survey. The survey is short and takes approximately 10 minutes to complete, depending on the volume of qualitative comments the participant provides. No follow-up is planned as the survey is administered in a face-to-face setting.

4. Describe any tests of procedures or methods to be undertaken. Testing is encouraged as an effective means of refining collections of information to minimize burden and improve utility. Tests must be approved if they call for answers to identical questions from 10 or more respondents. A proposed test or set of tests may be submitted for approval separately or in combination with the main collection of information.

Prior to using the CAPTAP survey with training participants it was pretested with a small group of potential respondents (less than 10) to determine the time required to complete the survey and ensure the questions are understandable and answerable by the intended respondents.
