The Rehabilitation Services Administration (RSA) is pleased to inform its grantees about the 704 Report for the FY 2008 reporting period (10/1/07 - 9/30/08). The revised 704 Report instrument and instructions, Parts I and II, can be downloaded at: <a href="http://www.ilru.org/TBD">http://www.ilru.org/TBD</a>.

#### **704 REPORT CHANGES**

The FY 2008 704 Report content is the same as last year, except for required changes in the race and ethnicity data collection protocol based on the *Final Guidance on Maintaining, Collecting, and Reporting Racial and Ethnic Data to the U.S. Department of Education* published in the Federal Register on October 19, 2007.

In addition, grantees have the option to complete and submit the 704 Report directly through the RSA Management Information System (MIS).

## **SUBMITTAL INSTRUCTIONS**

The SPIL must be submitted **both** electronically and in hard copy, as described below.

Part I is to be completed by designated state units (DSU) and the statewide independent living councils (SILC). Part II is to be completed by the Part C-funded Centers for Independent Living (CILs). The 704 Report submittal deadlines are as follows:

- For 722 States –No later than **December 31, 2008**
- For 723 States No later than **January 31, 2009**

#### Electronic

Emailed submittals must be sent to RSA at <u>TBD@ed.gov</u> and to the Independent Living Research Utilization (ILRU) at <u>TBD@bcm.tmc.edu</u>. Use the following procedures for naming the emailed 704 Report:

- For Part I (DSUs and SILCs), use the two letter state designator followed by the fiscal year designation. For example, Arizona's FY 2008 704 Report Part I would be identified as AZ.08. Include the phrase, "704 Report", in the email subject line.
- For Part II (CILs), use the two letter state designator followed by the CILs name or acronym and fiscal year designation. The Arizonans Building Liberty and Empowerment Center would be identified as AZ.ABLE.08 and the Sunshine CIL (in Arizona) would be identified as AZ.Sunshine.08. Include the phrase, "704 Report" in the subject line.

Submittal through the RSA MIS requires grantees to enter the 704 Report directly online. The
