USCIS previously published this information collection as an extension in the Federal Register on May 16, 2008, at 73 FR 28493, allowing for a 60-day public comment period. During the 60-day public comment period, USCIS decided to revise the Form N-400 instructions. Therefore USCIS is publishing this 30-Day information collection notice as a revision. USCIS did not receive any comments for this information collection.
