Flight Hours For Corporations Not U.S. Citizens N

Records on file with the Federal Aviation Administration (FAA) Civil Aviation Registry indicate that your aircraft was registered pursuant to Title 49 U. S. C. 44102(a)(1)(C), and 14 C. F. R. Section 47.9 of the Federal Aviation Regulations which relate to registration of aircraft by "Corporations not U. S. citizen". Section 47.9(f) requires that you submit a statement regarding flight hours accumulated every six months. If the aircraft is operated outside the United States during the reporting period, the statement must set forth the total time in service of the airframe during that period and the total flight hours accumulated by the aircraft within the United States during that period. To continue to be eligible for registration, at least 60 per cent of the total flight hours must be accumulated within the United States. If the aircraft was operated exclusively within the United States during the reporting period, a statement to that effect will meet the requirements of the regulation.

Your failure to submit the required report may result in action being taken to revoke the aircraft registration certificate.
