

Federally Reimbursable Interim Assistance (IA) is assistance from State or Local funds to an ٠ individual for meeting basic needs during the period (1) beginning with the first month for which such individual received an SSI dollar amount payment; or, (2) beginning with the first day for which the individual's benefits were suspended or terminated, if the individual was subsequently found to be eligible for such payments, and is paid an SSI dollar amount. You cannot be paid the difference between the IA prorated amount and the full IA amount from any other month in the IA period.

Assistance payments financed in whole or part from Federal funds (e.g. TANF) do not come within the meaning of interim assistance.

You must complete and submit the information on the screen "Enter IA Payments Made" within 25 working days to be eligible for reimbursement. If this information is not received timely, SSA will release back payments due to the SSI individual based on SSA rules. The Social Security Administration (SSA) will not reimburse you for the IA assistance you paid.






