3	<i>New Item</i>	N/A	Item included in an earlier survey of employer's awareness of health disparities. Will allow for comparisons to be made on awareness of HDs between employers, the general population, and physicians.
4	<i>New Item</i>	N/A	Respondents' awareness of major health disparities publications/campaigns impacts overall awareness of health disparities.
5	Q13	Reworded the item by excluding racial and ethnic category, and substituted "thinking about people like yourself"	Reduced the need to ask this question three times instead of once by adapting the item to reflect the respondents' perceptions of <i>themselves</i> instead of specific racial and ethnic groups.
6	Q11	Excluded response options d) housing, e) education, f) employment, and g) income	Response options did not focus on health disparities.
