In principle, RtI begins with research-based instruction and behavioral support provided to students in the general education classroom, followed by screening of all students to identify those who may need systematic progress monitoring, intervention, or support. Students who are not responding to the general education curriculum and instruction are provided to assess their progress and inform the choice of future interventions, including possibly special education for students determined to have a disability. Although typically targeted to students in grades K-3, many states have or are considering implementing a similar system at the preschool level. Below we refer to this method as RtI, although this method may be called something different in your state, such as Recognition and Response.
