SUBJECT: PFPA Migration Plan to Meet HSPD-12 Requirements

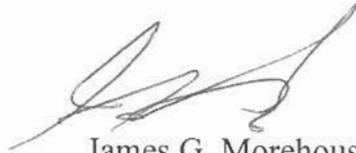
This memorandum provides Pentagon Force Protection Agency's response for the migration of individuals from the current local badges and building passes to the Common Access Card (CAC). In October 2006, the Defense Manpower Data Center (DMDC) will initiate the next generation CAC that will be compliant with Homeland Security Presidential Directive (HSPD)-12. Beginning October 2006, DMDC will issue the HSPD-12 compliant CAC to military, DoD civilians and contractors. This migration may take three and a half years to implement due to the normal transition of expiration of the current CAC. There are approximately 100,000 personnel within the Pentagon and delegated buildings and 89% will possess HSPD-12 compliant cards. The Pentagon and delegated buildings contain nearly 89,000 CAC-issued individuals.

The DMDC advocates use of the Defense Biometric Identification System (DBIDS) as an alternate credential for personnel who are not eligible for an HSPD-12 compliant credential. The DBIDS credential will be issued to contractors requiring physical access to a single DoD facility or a local region that employs regional DBIDS and will not have a requirement to visit other federal facilities. The DBIDS card will also be issued to other personnel requiring physical access but not eligible for an HSPD-12 compliant card (i.e. volunteers, vendors, personnel requiring infrequent access, etc.). The use of DBIDS will eliminate many base-level identification cards currently used for physical access.

An additional card will be authorized and possesses special visual or topology characteristics that are not available with the current CAC or DBIDS. This card will only be issued to individuals requiring access to certain locations or have mission-essential tasks such as deploying to support Continuity of Operations Plan (COOP) and are identified with a "3." Emergency workers will require an "EW" on their badge. Those individuals requiring concealed firearms will have an "A." on their card. These additional cards will only have visual identifiers and not electronic access controls.

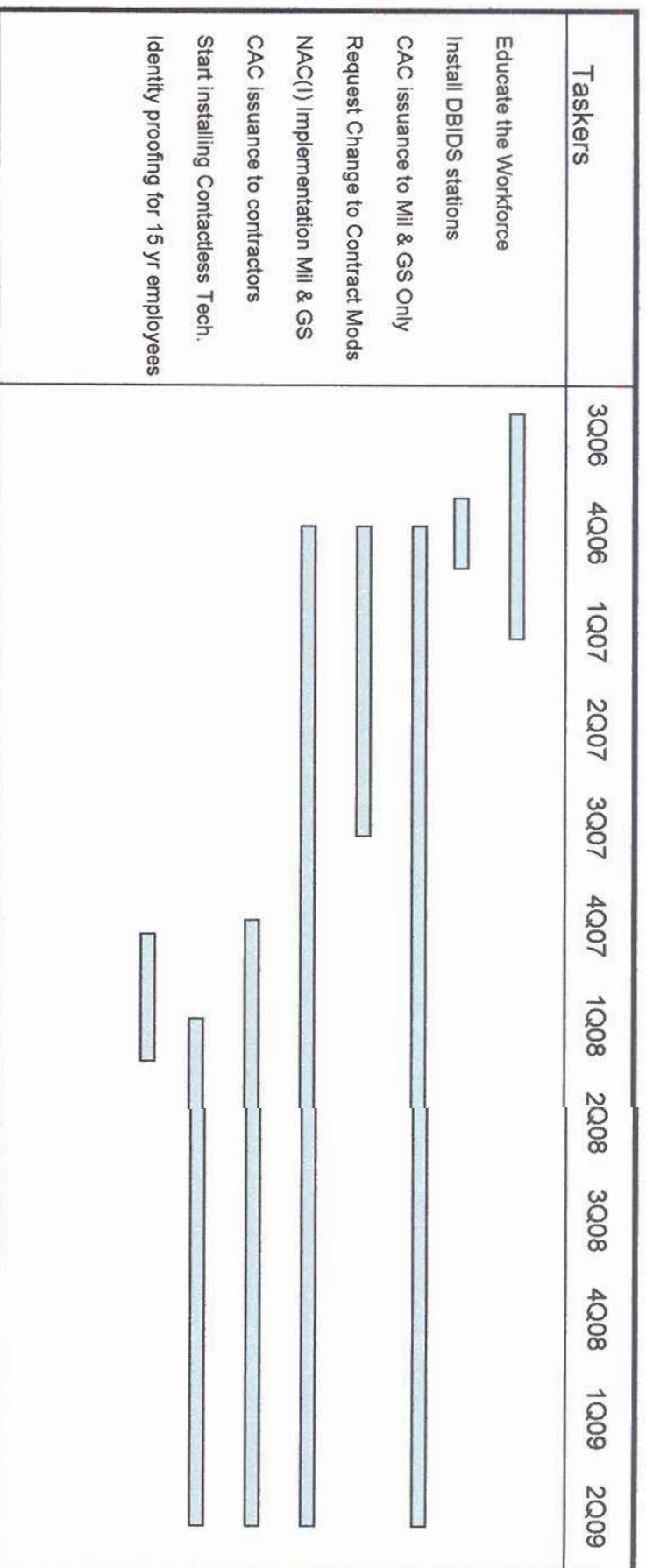
