Section 6011(e)(2)(A) of the Internal Revenue Code, as amended by section 7713 of the Revenue Reconciliation Act of 1989, Pub. L. No. 101-239 (1989), 103 State. 2106, requires certain filers of information returns to report these on magnetic media. Filers will be able to prepare their own pressure sensitive label as long as it contains the required information. Notice 210 provides the instructions for completing the media label.

The media label is used by filers to inform the IRS as to what type of information is contained on the media being submitted. IRS examines the information submitted to determine the feasibility of processing the tapes, tape cartridges and diskettes.
