### A. Justification:

The U.S. Department of Homeland Security (DHS), Immigration and Customs Enforcement (ICE) is improving community safety by transforming the way the Federal government cooperates with state and local law enforcement agencies via the Secure Communities initiative. To maintain Secure Communities, ICE must continue to collect detailed requirements and input from its state and local law enforcement partners to focus resources on assisting all local communities in the removal of high-risk criminal aliens as authorized by 8 USC §1231, *Detention and Removal of Aliens Ordered Removed*.

2. Indicate how, by whom, and for what purpose the information is to be used. Except for a new collection, indicate the actual use the agency has made of the information received from the current collection.

The data collected on this form is used by ICE to determine the fingerprint procedures and technological capabilities of state and local jails, governance, and basic jail booking statistics. This information will be used to prioritize and inform the strategy of the Secure Communities plan.

3. Describe whether, and to what extent, the collection of information involves the use of automated, electronic, mechanical, or other technological collection techniques or other forms of information technology, e.g., permitting electronic submission of responses, and the basis for the decision for adopting this means of collection. Secure Communities is a high level priority of the Department and Congress. Failure to implement the program will result in the failure to remove criminal aliens from the United States. The information only needs to be obtained during the initial phase of the program implementation.
