Other change**

- There are two changes regarding the IIEP APR.
 - The number of respondents and number of responses are the same. There's change in the number of annual burden hours. This calculation and the statement of explanation are presented in the following table.
 - Reporting Block. Item A3 of the IIEP APR data collection instrument, the Department (OME) will now allow grantees to report follow-up information on just a sample population of their students and not every student. More details regarding this change are included in the following table. Only a few grantees (two or three) will be impacted by this change.

Calculation

Total Annual Hours Current Record

40 hrs. x 61 grantees = 2,440 hrs.

Total Annual Hours New Record

30 hrs. x 61 grantees = 1,830 hrs.

Other Change(s)/Statement of Explanation

- (1) After having discussed the effectiveness of the data-collection instrument with grantees, OESE (OMI) has concluded that the information being collected (contact hours for individual students) does not warrant the burden of work. Therefore, OME no longer requires grantees to record the number of contact hours they have with each of their students, which has caused the burden hours to decrease.
- (2a) In the Reporting Block, Item A3 of the IIEP APR data collection instrument, grantees that have 150 or more students who acquire a GED would have the option of reporting follow-up data on a sample population of students that have acquired a GED rather than on every student that acquires a GED.

Therefore, projects that report 149 or less students acquiring a GED are still required to report follow-up data on every student.
