

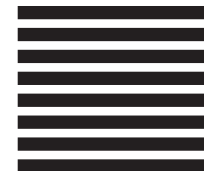

Your Answers Are Confidential

Federal law protects your privacy and keeps your answers confidential (Title 13, United States Code, Sections 9 and 214). They cannot be obtained with a Freedom of Information Act (FOIA) request.

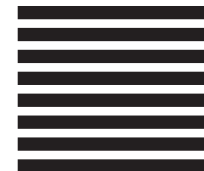
