**OVERVIEW**

The Minority Business Development Agency (MBDA) of the U.S. Department of Commerce is the only federal agency dedicated exclusively to fostering the establishment and growth of minority businesses in the United States. MBDA and its network of business centers serve minority entrepreneurs who are pursuing growth in size, scale and capacity. In doing so, minority firms are better positioned to create new jobs, impact local economies and expand into national and global marketplaces.

The MED Week Awards Program is designed to celebrate and recognize the outstanding achievements of minority entrepreneurs as well as individuals and organizations that have demonstrated leadership and commitment in advancing minority business enterprise. The diversity of the awardees, as it pertains to the constituency served by MBDA, is a key objective of the MED Week Awards Program.

The awards are commemorative and will be given in the following categories: Minority Construction Firm of the Year, Minority Manufacturer of the Year, Minority Retail or Service Firm of the Year, Minority Technology Firm of the Year, Minority Supplier Distributor of the Year, Advocate of the Year, Media Award, Distinguished Supplier Diversity Award, Access to Capital Award, Ronald H. Brown Leadership Award and Abe Venable Legacy Award for Lifetime Achievement.

National Enterprise Center (NEC) Awards will be given in all categories, except the Ronald H. Brown Leadership Award and the Abe Venable Legacy Award for Lifetime Achievement, in ceremonies in MBDA's Atlanta, Dallas, Chicago, New York and San Francisco National Enterprise Centers, respectively. The National MED Week Awards, which include all of the awards referenced above, will be given at the annual MED Week Awards Gala held in Washington, D.C.

## **INSTRUCTIONS FOR SUBMITTING NOMINATIONS**

- **Nomination packages are distributed by MBDA to MBDA funded organizations, non-governmental organizations and to other interested parties. The nomination package will also be accessible via the MBDA ([www.mbda.gov](http://www.mbda.gov)) and the MED Week ([www.medweek.gov](http://www.medweek.gov)) websites.**
- **Nominations may be submitted by individuals or organizations in any category applicable and may be submitted for more than one award category. Self-nominations are also permitted. In addition, nominations may be submitted by MBDA staff or by representatives of MBDA funded projects. However, nominations may not be submitted by members of the NEC or headquarters review panels or by MBDA Selecting Officials.**
- **Nominations should address the specific evaluation criterion applicable to the award category. Narratives should be thorough and concise, but should not exceed five pages total.**
- **The nomination package is comprised of the: (1) nomination form; (2) narratives addressing the specific evaluation criterion; and (3) biography of the nominee or an overview of the organization (as applicable).**
- **Do not include any additional materials, such as promotional materials, annual reports, etc., unless the question for the applicable category specifically calls for it.**
- **Do not submit photographs. Category winners will be asked to provide this item after the selection process is completed.**
- **Nominations may be sent by U.S. mail, courier service, or by electronic mail. However, the complete nomination package must be sent by only one of these methods. Nominees are advised that security screening could delay delivery of U.S. mail. Delivery by a courier service or by electronic mail is therefore recommended.**
- **Nominations for all MED Week awards, with the exception of the Ronald H. Brown Leadership Award and the Abe Venable Legacy Award for Lifetime Achievement, should be sent or emailed to the appropriate MBDA NEC office listed below, based on the nominee's principal place of business or residence (as the case may be). ## **NOMINEE ELIGIBILITY**

MBDA serves minority business enterprises that are owned or controlled by the following persons or group of persons: African American, American Indian, Alaska Native, Asian, Hispanic, Native Hawaiian, Pacific Islander, Asian Indian, and Hasidic Jews. Nominees are especially sought from these groups. Eligible nominees include, but are not limited to, business owners, business executives, nonprofit organizations, for profit firms and institutions, universities and colleges, and representatives of local, state and federal governments. The Minority Construction Firm of the Year, Minority Manufacturer of the Year, Minority Retail or Service Firm of the Year, Minority Technology Firm of the Year, Minority Supplier Distributor of the Year awards are reserved for presentation to a minority business. The remaining MED Week Awards are open to qualified nominees without regard to minority status.

## **SELECTION PROCEDURES - NATIONAL ENTERPRISE CENTER MED WEEK AWARDS**

1. Nomination packages for the Minority Construction Firm of the Year, Minority Manufacturer of the Year, Minority Retail or Service Firm of the Year, Minority Technology Firm of the Year, Minority Supplier Distributor of the Year, Advocate of the Year, Media Award, Distinguished Supplier Diversity Award, Access to Capital Award are submitted to the appropriate MBDA National Enterprise Center where they are reviewed for completeness. Partial or incomplete nomination packages will not be considered by MBDA.
2. Complete nomination packages for each award category are evaluated, rated and ranked by a review panel based on the evaluation criterion published in this brochure. The review panel shall be comprised of three persons, at least one of whom will be a full-time employee of MBDA.
3. The applicable MBDA NEC Director (or his or her designee) will serve as the Selecting Official for all National Enterprise Center MED Week Awards. In determining the award winners, the Selecting Official will consider the panel rankings and may also consider such other factors as the overall diversity of the nominee pool as it pertains to the objectives of the MED Week Awards Program and the constituency served by MBDA. However, the Selecting Official may decide not to make an award selection if MBDA does not receive any satisfactory nominations in a specific award category. In addition, the Selecting Official may select more than one award winner in a specific category depending on the quality of the nominations received. Prospective award winners will be reviewed by the Department of Commerce prior to an official selection.

## **SELECTION PROCEDURES – NATIONAL MED WEEK AWARDS**

1. Ronald H. Brown Leadership Award and the Abe Venable Legacy Award for Lifetime Achievement:
  - A. Nomination packages for these awards are submitted directly to MBDA headquarters where they are reviewed for completeness. Partial or incomplete nomination packages will not be considered by MBDA.

- B. Complete nomination packages for each award category are evaluated, rated and ranked by a review panel based on the evaluation criterion published in this brochure. The review panel shall be comprised of three persons, at least one of whom will be a full-time MBDA employee.
- C. The MBDA National Director (or his/ her designee) will serve as the Selecting Official for these awards. In determining the award winners, the Selecting Official will consider the panel rankings and may also consider such other factors as the overall diversity of the nominee pool as it pertains to the objectives of the MED Week Awards Program and the constituency served by MBDA. However, the Selecting Official may decide not to make an award selection if MBDA does not receive any satisfactory nominations in a specific award category. In addition, the Selecting Official may select more than one award winner in a specific category depending on the quality of the nominations received. Prospective award winners will be reviewed by the Department of Commerce prior to an official selection.
2. Minority Construction Firm of the Year, Minority Manufacturer of the Year, Minority Retail or Service Firm of the Year, Minority Technology Firm of the Year, Minority Supplier Distributor of the Year, Advocate of the Year, Media Award, Distinguished Supplier Diversity Award, Access to Capital Award:
- A. The nomination packages and the review panel evaluations for the National Enterprise Center MED Week award winners are submitted to MBDA headquarters for consideration for National MED Week awards in these categories. No other nominations will be considered.
- B. The MBDA National Director (or his or her designee) will serve as the Selecting Official for these awards. The Selecting Official will select the award winners based on a determination as to which Regional MED Week award winner best meets the evaluation criterion and the overall spirit and objectives of the MED Week Awards Program. However, the Selecting Official may decide not to make an award selection if MBDA does not receive any satisfactory nominations in a specific award category. In addition, the Selecting Official may select more than one award winner in a specific category depending on the quality of the nominations received. Prospective award winners will be reviewed by the Department of Commerce, prior to an official selection.

MBDA reserves the right to contact the nominator and the nominee of any National Enterprise Center or National MED Week Award in order to verify information submitted or to obtain additional information necessary to evaluate the nomination. Persons contacted by MBDA are under no obligation to provide this information, but should recognize that failure to provide the information may lower the chances of the nominee being selected as the winner of a MED Week award.

### **MINORITY CONSTRUCTION FIRM OF THE YEAR**

Presented to a minority firm that has achieved outstanding success in private or public sector construction projects and has exhibited revenue and job growth over a sustained period of time.

- Total revenue and number of employees. **40 Pts**
- Revenue growth and number of jobs created over a sustained period. **30 Pts**
- Challenges overcome- Technical, commercial, competitive or societal. **15 Pts**
- Economic, environmental or societal contributions. **15 Pts**

### **MINORITY MANUFACTURER OF THE YEAR**

Presented to a minority firm that has achieved significant success in employing new and innovative techniques that led to a significant increase in market share, job growth and customer satisfaction.

- Total revenue and number of employees. **40 Pts**
- Innovative techniques utilized and the results achieved. **30 Pts**
- Challenges overcome- Technical, commercial, competitive or societal. **15 Pts**
- Economic, environmental or societal contributions. **15 Pts**

### **MINORITY RETAIL OR SERVICE FIRM OF THE YEAR**

Presented to the minority firm that has achieved notable success in expanding its product line, expanding revenues, and creating jobs.

- New product lines or services implemented. **40 Pts**
- Total revenue and jobs created. **30 Pts**
- Challenges overcome- Technical, commercial, competitive or societal. **15 Pts**
- Economic, environmental or societal contributions. **15 Pts**

### **MINORITY TECHNOLOGY FIRM OF THE YEAR**

Presented to the minority company that has achieved notable success in bringing new technologies to market and/or expanded technology applications to increase efficiencies and jobs.

- Types of new or innovative technologies employed. **40 Pts**
- Revenues and jobs created over the past five years. **30 Pts**
- Challenges overcome- Technical, commercial, competitive or societal. **15 Pts**
- Economic, environmental or societal contributions. **15 Pts**

### **MINORITY SUPPLIER DISTRIBUTOR OF THE YEAR**

Presented to the minority company that has achieved outstanding success in penetrating domestic and global markets.

- How the nominee has penetrated global and domestic markets. **40 Pts**
- Revenues and jobs created. **30 Pts**
- Challenges overcome- Technical, commercial, competitive or societal. **15 Pts**
- Economic, environmental or societal contributions. **15 Pts**

### **ADVOCATE OF THE YEAR**

Presented to an individual or organization that has demonstrated significant accomplishment in advocating minority business enterprise as an economic force.

- Accomplishments related to the nominees' advocacy efforts. **40 Pts**
- Creativity in advocacy activities. **30 Pts**
- Challenges overcome- Technical, commercial, competitive, or societal. **15 Pts**
- Economic, environmental or societal contributions. **15 Pts**

### **MEDIA AWARD**

Presented to the print, broadcast or radio media organization that has achieved notable success in elevating public awareness of the positive impact of MBEs on the U.S economy.

- How the nominee has raised awareness and the results **40 Pts**
- Creativity and innovation in support of minority business enterprise. **30 Pts**
- Challenges overcome- Technical, commercial, competitive, or societal. **15 Pts**
- Economic, environmental or societal contributions. **15 Pts**

### **DISTINGUISHED SUPPLIER DIVERSITY AWARD**

Presented to the organization or individual whose business practices have had a significant impact on the growth and development of minority business.

- Increased dollar values of purchases from minority business enterprises over the past five (or more) years. **40 Pts**
- Innovative programs. **30 Pts**
- Challenges overcome- Technical, commercial, competitive, or societal. **15 Pts**
- Economic, environmental or societal contributions. **15 Pts**

### **ACCESS TO CAPITAL AWARD**

Presented to an individual or organization who has demonstrated outstanding leadership in the financial community by providing, facilitating, or promoting access to capital for minority businesses.

- How the nominee provided leadership and advocacy for access to capital. **40 Pts**
- Dollar value of loans or other financial instruments provided to minority businesses or individuals. **30 Pts**
- Challenges overcome- Technical, commercial, competitive, or societal. **15 Pts**
- Economic, environmental or societal contributions. **15 Pts**

**RONALD H. BROWN LEADERSHIP AWARD** is inspired by the outstanding leadership by the late U.S. Secretary of Commerce, Ronald H. Brown. As the first African-American to serve as the Department's Secretary, he was a staunch advocate for diversity in American business. The Award recognizes individuals who are willing to take risks to achieve change and who have demonstrated exceptional leadership by significantly enhancing the development of diversity in the domestic and worldwide economies.

- Innovations and improvements initiated by the nominee and the results. **30 Pts**
- Exceptional and effective leadership demonstrated by the nominee. **30 Pts**
- The extent to which nominee championed the development of diversity. **20 Pts**
- Types of awards received. **10 Pts**
- Community involvement and relationship with MBDA. **10 Pts**

**ABE VENABLE LEGACY AWARD FOR LIFETIME ACHIEVEMENT** celebrates high standards of excellence, dedication, and accomplishment over a *sustained* period of time. The award is granted to an individual who has played an integral role in the creative, technical or professional progress of minority business development over the course of his/her life.

- The role the nominee has played in the development of minority business enterprise over the past 25 (or more) years. **50 Pts**
- The management or programmatic improvements the nominee achieved. **30 Pts**
- Types of awards received. **10 Pts**
- Community involvement and relationship with MBDA. **10 Pts**
