Introduction

This information collection clearance package is being submitted by the Office of Surface Mining Reclamation and Enforcement (OSM) to continue collection authority under 30 CFR 875. This part establishes the requirements and procedures allowing States and Indian tribes to conduct noncoal reclamation under the Abandoned Mine Land fund as directed through legislation, Public Law 101-508. The information collection for 30 CFR 875 was previously approved by the Office of Management and Budget (OMB) and was given clearance number 1029-0103.

Specific Instructions

Supporting Statement for §875.13 - Certification of Completion of Coal Sites.

A. <u>Justification</u>

1. Explain the circumstances that make the collection of information necessary. Identify any legal or administrative requirements that necessitate the collection. Attach a copy of the appropriate section of each statute and regulation mandating or authorizing the collection of information.

OSM amended its Abandoned Mine Land Reclamation regulations in November 1993 which modified 30 CFR Subchapter R, Part 875 - Noncoal Reclamation, in order to conform with Title IV of the Surface Mining Control and Reclamation Act of 1977 (SMCRA), Public Law 95-87, as amended by the Omnibus Budget Reconciliation Act of 1990, Public Law 101-508 (November 5, 1990). This legislation expands the rights of States/Indian tribes which have certified the completion of all known coal problems to utilize State/Indian tribes share funds for noncoal reclamation purposes, including the protection, repair, replacement, construction, or enhancement of public facilities damaged by past mining practices or which exist in communities adversely impacted by present mining activities.

2. Indicate how, by whom, and for what purpose the information is to be used. In order to implement a noncoal reclamation program as set forth in Section 411 of SMCRA, a Governor of a State or equivalent head of an Indian tribe must certify to the Secretary that the State/Indian tribe has achieved all known coal related reclamation objectives. Section 875.13(a) provides the requirements for this certification. Briefly, a State/Indian tribe would have to provide a discussion of the process and rationale for its certification, in

conjunction with an analysis of the public involvement process used and any public comments received. This information would be used to assist the Director, OSM, in his/her certification concurrence finding as required by regulation, and ensure that the public had been properly canvassed to ascertain that all coal problems had in fact been addressed. Also, section 875.13(a) requires a State/Indian tribe to describe its ability to fund potential coal related problems that may occur after certification. This information would ensure that States/Indian tribes which have specific knowledge of potential future coal problems will reserve sufficient funds to address these problems when and if they occur.

30 CFR 875.15 implements section 411(f) of SMCRA. This section allows a State/Indian tribe to request funding notwithstanding the priorities in Section 411 for a public facility if a Governor or equivalent head of an Indian tribe determines there is a need for the construction of the public facility related to the coal or minerals industry in States or on Indian lands impacted by coal or mineral development. Funding is requested through submission of a grant application package, which includes forms OSM-47, "Budget Information Report", OSM-49, "Budget Information and Financial Reporting Form", and OSM-51, "Program Narrative/Performance Report Statement."

These forms have been approved separately by OMB and assigned information collection control number 1029-0059.

3. Describe whether, and to what extent, the collection of information involves the use of automated, electronic, mechanical, or other technological collection techniques or other forms of information technology, e.g., permitting electronic submission of responses, and the basis for the decision for adopting this means of collection. Also describe any consideration of using information technology to reduce burden [and specifically how this collection meets GPEA requirements.].

OSM anticipates that approximately one half of all certifications received from States/Tribes will be submitted electronically.

4. Describe efforts to identify duplication. Show specifically

why any similar information already available cannot be used or modified for use for the purposes described in Item 2 above.

No similar information pertaining to coal completion certification is collected by OSM or by other Federal agencies.

5. If the collection of information impacts small businesses or other small entities (Item 5 of OMB Form 83-I), describe any methods used to minimize burden.

The information being requested is the minimum amount necessary in accordance with sections 403, 404 and 411 of SMCRA for the Director to concur with the State's or Tribe's certification that all coal-related reclamation projects have been completed. Since OSM provides grants to Indian Tribes to conduct this collection activity there is no significant burden on these small entities.

6. Describe the consequence to Federal program or policy activities if the collection is not conducted or is conducted less frequently, as well as any technical or legal obstacles to reducing burden.

Since each coal completion certification is unique and conducted only once per State/Indian tribe, there is no available information or data that would satisfy the respective requirements in lieu of that supplied by the State/Indian tribe.

- 7. Explain any special circumstances that would cause an information collection to be conducted in a manner:
 - * requiring respondents to report information to the agency more often than quarterly;
 - * requiring respondents to prepare a written response to a collection of information in fewer than 30 days after receipt of it;
 - * requiring respondents to submit more than an original and two copies of any document;
 - * requiring respondents to retain records, other than health, medical, government contract, grant-in-aid, or tax records, for more than three years;
 - * in connection with a statistical survey, that is not designed to produce valid and reliable results that can be

generalized to the universe of study;

- * requiring the use of a statistical data classification that has not been reviewed and approved by OMB;
- * that includes a pledge of confidentiality that is not supported by authority established in statute or regulation, that is not supported by disclosure and data security policies that are consistent with the pledge, or which unnecessarily impedes sharing of data with other agencies for compatible confidential use; or
- * requiring respondents to submit proprietary trade secrets, or other confidential information unless the agency can demonstrate that it has instituted procedures to protect the information's confidentiality to the extent permitted by law.

Guidelines in 5 CFR 1320.5(d)(2) are not exceeded.

8. The regulations at 30 CFR 875 were published in the Federal

Register as a proposed rule on November 8, 1993 (56 FR 57376), to amend OSM's noncoal reclamation regulations at 30 CFR 875. No comments were received on the information collection requirements. The final rule was published on May 31, 1994, in the Federal Register (59 FR 28172).

To date, six States and Indian tribes have certified completion of coal problems. As OSM has not had a data collection for this section in a number of years, and does not anticipate any in the near future, no contact has been made at this time to respondents concerning the requirements.

On February 27, 2009, OSM published in the <u>Federal Register</u> (74 FR 8985) a notice requesting comments from the public regarding the need for the collection of information, the accuracy of the burden estimate, ways to enhance the information collection, and ways to minimize the burden on respondents. This notice gave the public 60 days in which to comment. However, no comments were received.

9. Explain any decision to provide any payment or gift to respondents, other than remuneration of contractors or grantees.

As required by SMCRA, OSM provides significant funding to States and Indian Tribes to conduct this collection activity.

10. Describe any assurance of confidentiality provided to respondents and the basis for the assurance in statute, regulation, or agency policy.

Not applicable. No confidential information is solicited.

Not applicable. Sensitive questions are not asked.

Estimated Burden Hours

For the purpose of this submission, OSM assumes that 1 respondent may submit an application for the certification of completion of coal site reclamation projects. Using an estimated average of 100 burden hours per respondent for reviewing instructions, searching existing data sources, gathering and completing the collection of information, the information collection burden would be 100 burden hours x 1 respondent or 100 burden hours.

Estimated Annualized Wage Cost

OSM will assume that we will receive one certification each year, and that each request will be prepared by an attorney, with a salary of \$56 (rounded) derived from Bureau of Labor Statistics at

At \$56 per hour, the cost to a respondent to prepare the certification would be $$56 \times 100 \text{ hours} = $5,600.$

Estimate of Cost to the Federal Government

OSM will review the one request we receive annually. OSM estimates that it will take approximately 80 hours to review and process the certification. At \$68 per hour for a program specialist with a GS 14 step 5 salary (based on OPM salary table http://www.opm.gov/oca/09tables/html/gs_h.asp and including 1.5 multiplier for benefits as sited above), the annual cost to the Federal government is \$\$68 per hour x 80 hours = \$5,440 total each year.

15. Explain the reasons for any program changes or adjustments reported in Items 13 or 14 of the OMB Form 83-I.

The estimate of the burden hours contained in this request is based on OSM's staff expertise and experience as a regulatory authority for State and Federal reclamation programs, and from discussions and experience gained during direct programmatic interaction with States/Indian tribes, i.e., respondents. This information collection request does not change the currently approved burden for 30 CFR 875.13.

There are no plans for publication or statistical use of this information.
