- (2) that any such withdrawn article remaining on board while the vessel is in port shall be safeguarded in the manner and to such extent as the port director for the port or place of arrival shall deem necessary; and
- (3) that failure to comply with the above conditions shall subject the master and/or owner to penalties and/or seizure of the vessel.
